Fox Hollow continues to see students make improvement in their reading skills. We have fewer students in upper grades needing to be in intervention groups and most of the students in lower grades are moving through skills without the need to repeat the skill lessons. Our MOY Acadience data shows that 59% of students have made typical or better progress. Grade level teams are using Acadience data and Walk to Read data to discuss student needs.
